2022-2023 WEEDS ACTION PROGRAM [Year 3] - 3rd Quarter to 29 April 2023

Private Property Inspections – Weeds Action Program 2022/2023

NEWA has been able to meet its WAP targets this month, with two months still in the Financial Year. The focus of inspections in now upon increasing our numbers of hectares inspected.

Like most businesses, NEWA has been impacted by the Easter and ANZAC Day holidays, with the additional days taken by staff either side of these breaks. With winter also approaching rapidly, all effort is upon closing out the year and achieving good results.

The agricultural show season has now been completed with all shows attended. We have 3 planned extension events where we have been invited to present, with a focus on weed and weed control in order to be prepared for the next dry period.



Inspection Charts (2022 to 2023)

The chart shown on the following pages highlights the properties that have been inspected to date (29 April 2023). The chart shows all four LCAs in the NEWA County Council area, and inspections that have been undertaken from 2017 to date. The chart shows the extent of inspections undertaken which cover the majority of landholdings. 
Tropical Soda Apple Project - Jan - April 2023

Initial inspections have been carried out across the majority of the Macleay Valley with the entirety of the far side of the river having been inspected and inspection reports distributed to landholders. The remaining inspections are focused on the lower end of the valley where road closures continue to hinder access. The attached maps gives further details.

Generally, landholders have been achieving high levels of suppression with one property seeming to have achieved eradication. However, Thungutti Land Council and Comara Station continue to have unacceptable levels of infestation with little to no evidence of any control work being undertaken.

Secondary inspections will need to be undertaken within the next 4 months across all properties to determine the level of compliance by each landholder. It is recommended that any property not meeting the requirement of the Control Order, be issued with an IBD to allow NEWA to undertake the work required and recover costs should the property not be compliant by the third inspection.

The major issue is that the requirements of the Control Order may not be achievable or could be defined as not "reasonably practicable." Discussions with DPI regarding a Control Zone may be of benefit, as an aim of high-level suppression, instead of eradication, may be achievable by the majority of landholders in the Macleay.



Communication, Education, Extension and Publicity Activities


